High Rollers Stake Abbott; Davis Check Sizes Increase

27% of Davis Total is \$100 or Less, 50% is \$10,000-plus. 3% of Abbott Total is \$100 or Less, 69% is \$10,000-plus. Davis Relies More on Out-of-State Dollars.

s a result of her abortion-filibuster Twitter moment, Senator Wendy Davis raised more than \$1.3 million last summer, with an astounding 49 percent of that total coming from grassroots checks worth \$100 or less. Last week Davis reported that she collected a total of \$12.2 million in the second half of 2013, with 27 percent arriving in denominations of no more than \$100.1

Opponent Greg Abbott reported that he raised almost \$11.6 million in the second half of 2013. Checks of \$100 or less accounted for just 3

percent of his total. At the other extreme, checks of \$10,000 and up accounted for 69 percent of his total and 50 percent of what Davis collected.

Davis reported collecting funds through three committees. Her officeholder PAC raised money throughout 2013. The Wendy Davis for Governor PAC reported its first donation on September 28, after reports that she would definitely run for governor. Starting in October Davis also claimed donations from the Texas Victory PAC, a joint venture with Battleground Texas (which seeks a Democratic majority).

Davis landed the two fattest checks. She reported that plaintiff attorney Steve Mostyn's firm and retired physician Carolyn Oliver gave her \$1 million apiece. Oliver, who gave \$90,000 to Bill White in 2010, told the *Austin American-Statesman* that Texas needs a new prescription because "our Texas government doesn't represent the fairness that I think Texans feel."

Abbott collected a total of \$900,000 in four big checks from Harold Simmons, who had a Texas monopoly on dumping low-level nuclear waste until his death in December. Los Angeles Dodgers owner Robert Patton gave Davis

\$250,000. Abbott and Davis each collected a \$200,000 check from different energy tycoons.

Davis reported \$1.3 million of her latest haul as *unitemized* contributions of \$50 or less. She provided no details about the sources of those funds, which accounted for 11 cents of every dollar that Davis raised in the cycle.

Abbott accounted for every cent that he received. He reported that 93 percent of his total came from Texas. In-state donors supplied just 74 percent of the money that Davis *itemized*.
