## Charter Schools Master Texas Civics Lessons

**Top Charter Chains Doubled Their Campaign Investments.** 

People affiliated with Texas' top six charter-school chains more than doubled campaign contributions in recent years as charter schools successfully lobbied lawmakers to increase the state's cap from a maximum of 215 privately operated public charters to 305.

The Associated Press <u>published</u> a variant of TPJ's charter numbers last month.<sup>1</sup> This report provides more details on the top contributors and recipients of charter-related political funds.

In the two election cycles preceding the 2013 charter-cap increase, big-six charter contributions more than doubled to a total of \$517,875. Houston-based KIPP Public Charter Schools and Harmony Public Schools drove the surge in political funds. KIPP boasts a board of wealthy business people. Meanwhile Harmony had the most contributors writing checks to politicians. This narrowed the contribution gap between those schools by the 2012 cycle.

The biggest charter-related contributions tracked here come from Houston businesspeople affiliated with KIPP. Yet charters are not the primary political issue for these donors. "I think charter schools are great," contractor and KIPP board member Stan Marek told the Associated Press, "but I'm not going to send money to X politician for that alone."

Houston energy investors John and Laura Arnold donated \$10 million to KIPP. Yet Laura Arnold did not appear to have charters on her mind when she gave \$10,000 to Wendy Davis hours after the senator's famous 2013 filibuster against abortion restrictions.

Harmony contributors—who dominate charter contributions of less than \$10,000—may have a more disciplined focus on charters. A recent *Lobby Watch* discussed ties between Harmony's Turkish immigrant founders and exiled Muslim leader Fethullah Gulen. One criticism of Harmony is that Texas' largest charter chain steers construction, technology and other school contracts to fellow members of this Turkish immigrant community. Such contracts could make the business interests of some Harmony contributors indistinguishable from the charterexpansion agenda.

Some Gulen-tied contributors are not included in the data presented above because researchers found no evidence that they had served as Harmony employees or board members. Several of these contributors run Harmony contractor companies TDM Construction and Brighten Technologies. The Turquoise Council of Americans and Eurasians and the Raindrop Foundation are Gulen-related groups that pay for Texas lawmakers to go on junkets to Turkey.
