Texas GOP and Its Big Three Bag Enterprise-Fund Millions

Companies Winning \$307 Million in State Awards Contribute \$5.3 Million to Perry, Dewhurst, Straus and Their Party

he Republican Party of Texas and three state politicians who control the Texas Enterprise Fund (TEF) collected \$5.3 million in political money from donors affiliated with \$307 million in Enterprise Fund grants.

An analysis of 106 Enterprise Fund awardees finds that political committees, executives or investors¹ associated with 38 state-funded projects contributed \$3.6 million since 2000 to Governor Rick Perry, Lieutenant Governor David Dewhurst and House Speaker Joe Straus—the very officials who oversee TEF. TEF-linked contributors gave almost \$1.7 million more to the Republican Party of Texas.

The No. 1 recipient of TEF political funds is Governor Perry, who lobbied to create this taxpayer-financed job fund in 2003. The governor has collected more than \$2 million in TEF-tied contributions, up from the \$1.7 million that he had collected two years ago.²

Perry's top TEF contributor is Houston Texans owner Robert McNair, a major investor in Lexicon Pharmaceuticals. Lexicon is a partner in the Texas Institute for Genomic Medicine (TIGM), which received an unsurpassed \$50 million TEF award in 2005.³ TIGM is a prime example of how TEF fabricates its job-creation claims.⁴

Dewhurst collected \$1.3 million in TEF money. His top TEF contributor is James Leininger, who invested in TIGM and the biotech firm Gradalis, Inc. Gradalis' investors made huge investments in Dewhurst and Perry and then landed unprecedented grants from three major Texas slush funds.

Before Leininger invested in Gradalis, he and businessman Jimmy Mansour made a costly, failed legislative push for school vouchers; they also guaranteed the \$1.1 million campaign loan that helped Perry narrowly win his 1998 lieutenant governor race. To avoid conflicts, Mansour sold his Gradalis stake in 2009. He did so after Dewhurst appointed Mansour to the board of the Cancer Prevention and Research Institute of Texas (CPRIT) and as Gradalis investors began landing grants from three different state slush funds.⁵

Texas' Emerging Technology Fund awarded \$1.75 million to Gradalis in 2009. A year later TEF awarded \$3 million to G-Con, LLC, a company in which Gradalis owned a 10 percent stake.⁶ CPRIT also awarded \$748,905 to Gradalis in 2010.

While Mansour and Leininger long backed Texas' top GOP leaders, Gradalis and G-Con principal David Shanahan began showering Perry and Dewhurst with money shortly before his companies began to land extraordinary grants of public funds. And Austin Gradalis investor John McHale, who long backed Democratic candidates, made an uncharacteristic

\$100,000 contribution to Perry in this period, followed by \$25,000 more in 2012.8

The No. 3 TEF contributor is Drayton McLane. His Temple-based McLane Advanced Technologies landed a \$1 million TEF grant in 2009. McLane gave well over \$500,000 to TEF's overseers led by Governor Perry. McLane also gave \$100,000 to the main super PAC backing Perry's 2012 presidential bid. Perry's Make Us Great Again presidential PAC also plucked \$50,000 from poultry king Joe Sanderson, the No. 4 TEF contributor. TEF awarded \$500,000 to Sanderson Farms in 2006.

House Speaker Joe Straus collected the least TEF-related cash. TEF began doling out state grants before Straus became a freshman lawmaker in 2005. Rep. Straus did not exercise major control over TEF until he was elected speaker in 2009. Straus raised \$232,800 in TEF-related contributions, collecting 90 percent of it as speaker. Robert McNair is Speaker Straus' top TEF contributor.

James Leininger is the No. 1 TEF contributor to the Republican Party of Texas, which received \$1.7 million in TEF-related money. •
