Predatory Lenders Invest \$4.2 Million in Politicians Industry Adopts Offensive Strategy

he predatory lending industry has spent a stunning \$4.2 million on state politicians over the past two elections, including more than \$1 million from Cash Store chief Trevor Ahlberg of Irving (25 percent of total). These heavy expenditures helped a defensive industry seize the offensive.

As recently as 2011, the industry spent much of its political capital fighting off six reform bills, including one by conservative Rep. Tom Craddick, who became disgusted by the abuse of a constituent. Midland maid Linda Lewis borrowed \$6,300 to pay for her stepson's funeral. After \$12,000 in payments, she had not reduced her principal by one cent.

Texas Lawmakers have failed to regulate this industry, which extracts annual percentage interest rates of 391 to 521 percent from the working poor on payday or auto-title loans. Responding to this state vacuum over the past six years, 42 Texas cities have enacted ordinances that restrict the principal and the rollovers on such loans.

This session the industry recruited legislators to attack such ordinances. Identical Senate and

House bills would prohibit local governments from regulating these financial transactions in any way. Sponsoring those twin bills (SB 1530 and HB 3081) are Sen. Craig Estes and Reps. Giovanni Capriglione, Ryan Guillen and Drew Springer.

SB 2178 and HB 3947 by Sen. Don Huffines and Rep. Jodie Laubenberg would allow lenders burdened by an ordinance to sue the local government to block enforcement (quite a proposition for two lawmakers who took \$60,500 from Texans for Lawsuit Reform).² None of the industry's offensive bills have made it to the House or Senate floor. The last hope for predatory lenders is to amend the provisions to other bills.

All six sponsors of these offensive bills are major recipients of industry contributions, ranging from Rep. Springer's \$9,200 to Sen. Huffines' \$55,000. All but Rep. Laubenberg count Trevor Ahlberg among their top industry donors. This might spawn Ahlberg conspiracy theories but for the fact that—atop a green grassy knoll—the Cash Store king gave cash to no fewer than 80 current lawmakers (61 percent).

Predatory lenders meanwhile appear to have fought off a slew of reforms again this session. Only one was approved by a full legislative chamber. The House overwhelmingly passed Rep. Scott Cosper's symbolic HB 2008. It merely expresses state support for existing federal protections on loans to military personnel. This bill is languishing in the Senate Veterans Affairs Committee. Only one other reform was considered by a full legislative chamber. On a 76-66 vote, the House rejected Rep. Chris Turner's modest measure to restrict the industry's use of telemarketing calls to goose business (HB 877).

Even less successful were reforms to address predatory loan costs and enforcement. Two cost-related bills never got hearings. They were Rep. Tomas Uresti's proposal to cap the total cost of the loans at 25 percent of the principal (HB 1733) and Sen. Jose Menendez's SB 1155 to

include more fees in calculating what constitutes an illegal usurious interest rate. The House Investments and Financial Services Committee held a hearing on Rep. Diego Bernal's bid to prohibit loan extensions or rollovers unless a lender documents that the borrower can afford one. But the committee took no further action on HB 741.

Two enforcement reforms never made it to a full chamber floor. Rep. Sylvia Garcia's SB 1121 would make it harder to prosecute the signer of a bounced, post-dated check for criminal theft. HB 975 by Rep. Helen Giddings would restrict the ability of lenders to pursue criminal charges against borrowers or to use criminal threats. Finally, Rep. Craddick's HB 1134 would preempt the preemptors. It would authorize local governments to regulate consumer lenders and would impose many other restrictions on consumer loans. The House Investments and Financial Services Committee bottled Craddick's bill up tight.

Gov. Greg Abbott pocketed \$520,224, or 12 cents of every predatory dollar. Lt. Gov. Dan Patrick followed (\$284,914), receiving 7 percent of all industry money. To appreciate how this understates what these two leaders got from the industry, look no further than the No. 3 recipient of predatory loan money: the Republican State Leadership Committee (\$275,000). The top recipients of its funds were Abbott (\$100,000) and Patrick (\$74,038).

Indicted Attorney General Ken Paxton ranked No. 4, raking in \$186,900 from the predatoryloan industry (which secretly paid more than

> \$450,000 to install Utah's general in attorney 2012). Speaker Joe Straus was close behind, bagging \$185,250. Rep. Dan Flynn (\$115,900) was the only rank-and-file lawmaker to clear six predatory figures. All four of these politicians received their biggest industry contributions from the top four predatory-loan contributors:

Ahlberg, title-loan king Rod Aycox of LoanMax, the Texas Consumer Finance Association and Texas Consumer Lenders.

Houston Rep. Gary Elkins swings both ways as both a contributor and recipient of predatory money. Elkins is an executive of payday lending company Power Finance, which triggered criminal complaints in Dallas and San Antonio for failing to comply with local lending ordinances. Elkins, the industry's No. 15 donor, personally doled out almost \$50,000 in contributions (the chief beneficiary being Attorney General The Paxton). Elkins Campaign, meanwhile, received \$10,000 from predatory-lender interests led by Consumer Lenders and the Texas Consumer Finance Association. The Elkins Campaign gave that same amount of \$10,000 to the Texas House Leadership Fund benefitting Speaker Straus. Speaker Straus appointed Elkins chair of the House Government Transparency and Operation Committee.
