Texas Textbook Lobbying Drops After Education Board Loses Clout

ompanies selling instructional materials to schools slashed Texas lobby expenditures after 2011, when the Texas Legislature finally hobbled the embarrassing influence that the State Board of Education long exercised over educational materials.¹

Previously school districts generally could only spend state funds on materials approved by the State Board. In a state that otherwise aspires to


excel in science, board extremists held texts hostage to their views on birth control, pollution, civil rights and evolution.

In 2011 State law-makers passed a bill² that grants schools funds for instructional materials. Schools can bypass state-approved materials, provided that they cover the board's TEKS curricula standards.³

Lobby Watch wondered if decentralizing curriculum control would diminish lobby spending by companies that market such materials.

The accompanying graph shows that the industry paid Texas lobbyists up to \$1.4 million in 2012, a 40 percent drop from the \$2.3 million it spent in the preceding non-legislative year of 2010. In a state with inflationary lobby spending, this drop is significant.

The dip in lobby expenditures occurred at a time when many new start-up companies are producing instructional materials, encouraged by a shift to electronic materials that slash the costs associated with traditional textbooks. Despite new entrants, the number of instructional materials companies lobbying in Texas dropped from 20 in 2010 to 13 in 2012.

Electronic materials are easier to update and to tailor to the needs of individual school districts. This could allow some districts to teach children that humans and dinosaurs walked together on Earth, while others teach that this is a biblical fantasy with no basis in the fossil record. For the species *Texasaurus Rex*, such pedagogical variation would amount to halting progress.
