Industrial Users, Urban Sprawl Drive Big Texas Water Projects

The top organized interests pushing water infrastructure projects in Texas in recent years have been industrial water consumers and the industries that build and sell new homes.

In the 2011 dress rehearsal that preceded the current water-infrastructure push, H2O4Texas PAC spent \$330,100 helping to pass a constitutional amendment to finance such projects with state bonds. The *Austin American-Statesman*¹ recently reported on a TPJ analysis that finds that 62 percent of that PAC's money came from industrial water

gave \$54,500 to promote new subdivisions in a parched, fast-growth state.

H2O4Texas PAC derived 12 percent of its funding from the bottled-water industry, which fears renewed attempts to finance water projects with a <u>bottled-water tax</u>.

Two years after voters authorized the Texas Water Development Board to issue state bonds lawmakers now propose letting that same board tap the state's Rainy Day Fund to make up to \$2 billion in water-project loans.²

Propelled by water-thirsty frackers, energy and petrochemical industries gave \$197,000 to H2O4Texas. Another industrial water drinker, Texas Instruments, also gave.

Residential real estate interests provided 17 percent of the PAC's funding. Trade groups representing homebuilders and Realtors

All H2O4Texas PAC Contributors

The 26 contributors that bankrolled H2O4Texas PAC also gave state political candidates almost \$8.3 million during the 2010 and 2012 election cycles. Governor Rick Perry captured more than \$1 million of this money; Attorney General Greg Abbott also approached the \$1 million mark, surpassing Lieutenant Governor David Dewhurst and Speaker Joe Straus.

The only rank-and-file lawmaker to claim more than \$100,000 from H2O4Texas sources was Senator Troy Fraser. Senate Natural Resources Committee Chair Fraser has suggested that the Texas Water Development Board is not up to the task of overseeing \$1 billion in infrastructure loans. Fraser is urging his fellow part-time legislators to sack the board's part-time appointees and to replace them with full-time professionals.³ This would allow Fraser's boyhood friend, Governor Perry, to handpick a new board to oversee a huge new pot of state funds.

Lawmakers are growing skeptical of state programs that often appear to be gubernatorial slush funds (i.e. the <u>Texas Enterprise Fund</u>, the Emerging Technology Fund and the Cancer Prevention and Research Institute of Texas). This time legislators should invest more time in advance to design tough safeguards that might prevent the proposed water-project bank from becoming Texas' next political slush fund.
