Texas' Top 185 Contributors Spent \$131 Million on 2016 State Elections

Texas' top 185 individual and institutional political contributors spent from \$250,000 to \$9 million apiece during the two-year 2016 election cycle. These top 185 contributors collectively spent \$131 million, or 67 percent of the \$195 million raised by all candidates for Texas public offices during that period.
