## Donor-Appointees Gave the Governor \$17 Million

## I. Summary

- Texas Governor Rick Perry tapped 3,995 appointees 5,662 times to serve on hundreds of state agencies, boards and commissions between January 2001 and February 23, 2010 (some appointees were appointed multiple times).
- From 2001 through June 2010 Perry's campaign received \$17,115,865 from 921 of these appointees or their spouses. Gubernatorial appointees accounted for an impressive 21 percent of the \$83.2 million that Perry's campaign has raised since 2001.
- Perry's most-lucrative appointee is Wendy Lee Gramm, whom he appointed to the A&M Board of Regents and the Texas Tax Reform Commission. The U.S. Senate campaign of Gramm's husband transferred \$610,000 to Perry's campaign in 2002. It was the largest same-day contribution of the governor's political career.
- Only two other appointees gave Perry more than \$450,000 apiece: Peter Holt and T. Dan Friedkin. Perry appointed both of them to the Parks and Wildlife Commission. Parks and Wildlife is Perry's favorite appointee fishing hole. He bagged more than \$2 million from this commission (\$118,477 per appointee).
- A&M Regents were Perry's No. 2 source of appointee cash, yielding \$113,127 per appointee. Four A&M appointees besides Wendy Gramm gave the governor more than \$200,000 apiece.
- Inaugural Committee appointees gave the governor an average of \$102,194 apiece, making this Perry's No. 3 source of appointee contributions.
- University of Texas regents ranked fourth, giving Perry an average of \$83,463 each.

## II. Introduction

As Texas' longest serving governor, Rick Perry appointed 3,995 people to 592 boards, committees, councils, corporations, task forces, compacts, authorities, teams, groups and departments as of February 2010 (he appointed some of them to multiple posts). The governor has been in office so long that he has outlived 80 defunct state entities upon which his appointees once served. Yet Texans should not forget the sacrifices of Perry's appointees. This includes the 921 appointees who contributed to Perry's campaign or had a spouse that did so. These donor-appointees supplied \$17.1 million of the \$83.2 million total that Governor Perry's campaign raised since 2001 (donations occurred before and after the appointments). This political patronage system accounts for an impressive one out of every five dollars ever raised by Perry's gubernatorial campaigns.



### **Governor Perry's Donor-Appointees at a Glance**

#### CORRECTION

Today appointees account for 21 percent of all the money that Perry has raised since 2001. Analyzing a much smaller appointee universe, a 2006 edition of "<u>Governor Perry's Patronage</u>" found that gubernatorial appointees contributed \$4.5 million to Perry, which was 10 percent of what he had then raised.<sup>1</sup> An earlier edition of this report compared that percentage to the 21 percent figure found in 2010. That was an invalid comparison because the current study is based on better data than the earlier one. While the first study was based on an incomplete Perry appointee data going back to December 2002, this study tracks appointees who Governor Perry tapped for the two preceding years--as early as January 2001. During that early period, Governor Perry named more than 1,000 appointees who were not in the appointee database used for TPJ's first patronage study. Missing campaign contributions by those appointees, artificially reduced the percentage of campaign funds coming from appointees. Using a more complete appointee data set, shows that Perry's campaign has consistently raised between 20 percent and 21 percent of its money from appointees. TPJ regrets the error.

Evidence of a squeeze on gubernatorial appointees leaked out of Lubbock in late 2009. Two Texas Tech



appointees told the *Austin American-Statesman* that Perry campaign intermediaries pressured them to resign after they endorsed Perry's primary opponent, Kay Bailey Hutchison.<sup>2</sup> The sources for the story, ex-Tech Regents Mark Griffin and Windy Sitton, contributed less than \$4,000 each to Perry.<sup>3</sup>

Much of this report was completed when researchers discovered a grievous error. They had failed to credit Wendy Lee Gramm with the truckload of campaign cash that her husband transferred to Perry's campaign as then-Senator Phil Gramm retired from Congress in late 2002. That \$610,000 from Friends of Phil Gramm was the largest same-day contribution of Perry's career.<sup>4</sup> With the \$613,000 that the Gramms donated to Perry over the years, Wendy Gramm is Perry's No. 1 donor-appointee. Perry appointed Wendy Gramm to be a regent of his A&M alma mater in 2001; in 2005 he appointed her to the Tax Reform Commission. Meanwhile, as vice president of UBS investment bank, Phil Gramm pitched the Governor's Office on unsuccessful schemes to privatize the Texas Lottery and buy "dead-peasant" life insurance policies on state employees (UBS hired Governor Perry's son around that time).<sup>5</sup>

Texas governors have a rich history of using their appointment powers for patronage. It is difficult to compare Perry's patronage to that of his predecessors due to his unprecedented gubernatorial stint and because this is the most comprehensive study of its kind.<sup>6</sup> Historically, Parks and Wildlife Commission appointments and university regents appear to be some of the fattest patronage plums, perhaps because they channel the twin Lone Star obsessions of hunting and football.<sup>7</sup>

Besides Wendy Gramm, the only other donor-appointees to give Governor Perry more than \$400,000 apiece are wheeler dealers who landed coveted

Texas Parks & Wildlife Commission slots. San Antonio Spurs owner Peter Holt made a fortune off the nation's largest Caterpillar equipment dealership. T. Dan Friedkin owns one of the planet's biggest Toyota dealerships.

Toyota announced in 2003 that state and local incentives helped persuade it to build a new truck plant in San Antonio. Governor Perry has said that courting Toyota inspired the creation of the Texas Enterprise Fund, the state's "dealcloser" fund that gives tax dollars to private companies to locate or expand in Texas.

Perry's Democratic challenger, Bill White, recently suggested that Texans for Rick Perry is a deal-making fund in its own right. The Enterprise Fund awarded \$8.5 million to Caterpillar, Inc. in 2009 to build a plant in Seguin that promises to employ 1,714 workers by 2015. In May 2010 White denounced this state Caterpillar grant as a "kickback" to Perry donor Peter Holt. "I wish I could say I had a big role in bringing them [Caterpillar] here," Holt told the *Houston Chronicle*, "but they were already rolling when I got involved."<sup>8</sup>

Another appointee in the news is Clifton L. Thomas, Jr., the Victoria-based owner of Speedy Stop convenience stores. Thomas contributed \$251,000 to Governor Perry, who appointed him to the Guadalupe-Blanco River Authority. Thomas is the lead investor behind a proposal to build a simulcast horseracing facility outside Austin.<sup>9</sup> The plan requires approval by Perry appointees to the Texas Racing Commission.

This deal is complicated by ongoing litigation that involves competing claims to the racetrack license that Thomas wants to develop. One litigant asserting these claims is Bryan-based insurer Phil Adams, a Texas A&M University Regent who contributed \$259,914 to Perry's campaign and who has employed Perry's daughter. Adams invested in the racetrack license with Houston trial lawyer Michael Gallagher,<sup>10</sup> who contributed \$150,000 to Perry in recent years (and nothing to Bill White). This trial-lawyer donor has yet to land *his* gubernatorial appointment.

## **III. Most Expensive Offices**

#### Parks & Wildlife Seats Averaged \$118,477

Ý

The Parks & Wildlife Commission ranked is the state's most expensive office. Governor Perry collected an average of \$118,477 from the 17 people whom he appointed to this commission. Fifteen of these appointees contributed to the governor's campaigns, with five contributing more than \$200,000 apiece (Holt, Friedkin, chemicals executive S. Reed Morian, beer distributor J. Robert Brown and developer Ned Holmes). Governor Perry bagged more than \$2 million from his appointees to this agency.

#### Texas A&M Regent Seats Averaged \$113,127

UT Regents would have surpassed their cohorts at A&M but for all the campaign cash that Phil Gramm collected while deregulating the banking industry and transferred to the Texas Governor's Mansion. Led by Wendy Gramm, the governor collected more than \$2 million from 14 of the 18 people he tapped as A&M Regents. Other A&M regents who gave the governor more than \$200,000 apiece are: Clear Channel Communications founder Lowry Mays (father-in-law of Congressman Michael McCaul), insurer Phil Adams, Ex-TXU Corp. chief Erle Nye, and the late Dallas car dealer J.L. Huffines.



#### **Inaugural Committee Seats Averaged \$102,194**



The 21 people that Governor Perry appointed to his 2003 and 2007 inaugural committees gave him a total exceeding \$2.1 million. Perry collected the most from Michele "Mica" Mosbacher and her late husband Robert Mosbacher, Sr. of Mosbacher Energy (\$411,534).<sup>11</sup> The other inaugural donors who gave more than \$200,000 apiece are: Paul Foster of El Paso-based Western Refining Co., Ramona Bass of Fort Worth's oil-rich Bass family, Dallas real estate executive Moshe Azoulay, insurance executive Phil Adams and Dellionaire Mort Topfer.

#### UT Regent Seats Averaged \$83,463

Governor Perry took almost \$1.7 million from 14 of the 20 people whom he tapped as University of Texas Regents. Regent Paul Foster graduated first in this class, giving the governor \$370,157. Other regents clearing \$200,000 were engineering firm executive James Dannenbaum, investor R. Steve Hicks and Robert Rowling. Rowling's TRT Holdings, which owns Gold's Gym, recently gave \$1 million in corporate funds to American Crossroads, the Karl Rove operation pushing Republican majorities in Congress.<sup>12</sup> UT Regent appointee Colleen McHugh, who gave \$3,137 to Perry's campaign, helped the governor finagle a sweet personal tax break on a Hill Country investment property.<sup>13</sup>

#### Camino Real Regional Mobility Authority Seats Averaged \$72,396



Governor Perry appointed two people to El Paso's Camino Real Regional Mobility Authority. While both appointees are Perry donors, it was the \$140,291 that mortgage broker Harold Hahn gave Perry that accelerated this local transportation board into the donor-appointee big leagues.

#### Tax Reform Commission Seats Averaged \$70,250

Buoyed by Wendy Gramm, the Perry campaign withheld a total of almost \$1.7 million from 11 of the 24 people whom he appointed to the 2005 Tax Reform Commission. Other appointees who surpassed the \$200,000 bracket were El Paso builder Woody Hunt, James Dannenbaum and Robert Rowling. Tax-reform appointees gave Perry \$1.7 million.

#### **Texas Tech Regent Seats Averaged \$64,343**

Governor Perry collected more than \$1.2 million from 15 of the 20 people whom he appointed as Texas Tech Regents. Insurance executive Larry Keith Anders and banker Lawrence "Rick" Francis were the highest Tech regents, giving Perry well over \$200,000 apiece.



#### Select Commission on Higher Education Seats Averaged \$59,482

Governor Perry counts five out of the six people that he selected for the now-defunct Select Commission on Higher Education as donors. Most of the \$356,894 that the governor got from this commission came from El Paso builder Woody Hunt.

#### **University of Houston Regent Seats Averaged \$48,714**

Fourteen of the 19 people that Governor Perry appointed as University of Houston Regents gave him a total of \$925,557. Michele "Mica" Mosbacher and her late husband coughed up the most. Landry's Restaurants President Tilman Fertitta is this regency's next-largest Perry donor. The Fertittas own Nevada casino interests and have pushed to legalize high-stakes gambling here.



## **IV. Big-Donor Appointees**

This table lists 140 appointees who, along with their spouses, contributed from \$15,000 to \$613,000 to Governor Perry's campaign. These top contributor-appointees supplied 91 percent of the money that the governor received from appointees. They also account for 19 cents of every dollar ever raised by Perry's gubernatorial campaigns.
